HEALTH PROTOCOL

Obligation to report immediately if a family member is a contact case or a proven covid case, the isolation of the child will be implemented according to the ARS, The various health protocols set by the ARS will be implemented in the event of an evolution of covid

Welcome children aged between 8 months and 3 years. Depends on availability.

Three formulas are proposed:

Children who attend the nursery for morning and lunch must arrive between 8h30 and 9h15, and be collected between 12h and 12h15

Children who attend the nursery for the afternoon and snack must arrive between 13h30 and 14h30 and be collected between 16h30 and 17h30.

Children who attend the nursery all day arrive between 8h30 and 9h15 and be collected between 16h30 and 17h30.

We are unable to accept children outside these times.

If the child has an allergy or is asthmatic, please provide a doctor's prescription.

Vaccinations

In order for us to be able to check obligatory vaccinations, parents must provide the health card upon arrival before the child enters the nursery.
